

Put Your Arizona Tax Credits to Work!



How the Tax Credit Works*

You can make a tax credit gift to Boys & Girls Clubs of the East Valley of any amount (please see below for more details). When you file your Arizona taxes, you can claim a **dollar-for-dollar** Arizona Charitable Tax Credit that will either **reduce your tax liability** or **increase your refund**.

Maximize Your Tax Credit Opportunity by Giving Two Tax Credits to Boys & Girls Clubs of the East Valley:

- Qualifying Charitable Organization Tax Credit (Boys & Girls Clubs of the East Valley)
- Public School Tax Credit (Mesa Arts Academy)

For Example:

- **If you owe:** If you owe \$1,000 in state income tax, and you donate \$800, you may subtract the \$800 from your tax bill and pay the state only \$200.
- **If you DON'T owe:** If you owe nothing in Arizona State income taxes, and you donate \$800, you will get a refund of at least \$800 back from the state — what a great way to give to Boys and Girls Clubs of East Valley and get your money back, dollar-for-dollar!

Great News! The Tax Credit is available to you even if you do not itemize your deductions on your taxes.

If you make your direct contribution to Boys & Girls Clubs of the East Valley, and/or Mesa Arts Academy, it must be received prior to your tax filing.

* Tax circumstances are different for everyone; please consult your tax advisor in order to receive the Arizona Qualifying Charitable Organization Tax Credit and/or Public School Tax Credit for the year. Please consult your tax advisor for federal income tax information.
